Old Business

Requests must be submitted to Karasov by Dec. 14. They are due at CALS by Jan. 4, 2013.

New Business:

Remodel of Room 104 (Karasov): Karasov presented a diagram of the proposed remodel for Room 104. The desks will be movable and the room orientation will be flipped so that the entrance will be at the back of the room. Capacity will likely be less than the current 63. Karasov will share the remodel design at the next Hub meeting.

Change in number for cross-listed course: Kruger announced that the Forestry Undergraduate Curriculum Committee has approved a change in the course number for Environmental Studies from 375 to 371. This course is cross-listed in FWE and is an option for Forestry undergraduate students. No further action was required by the faculty.
